## City of Omaha Hawk Field Rules Effective June 26, 2020

- 1. All persons operating R/C aircraft from Hawk Field or flying off the lake at Standing Bear Lake Recreation Area must display a valid field permit. Field permits can be obtained from Omahawks R/C Inc. upon proof of a valid AMA membership and payment of the required membership fee. Visitors may fly in Board approved events or as a guest of a permit holder.
- 2. All persons operating R/C aircraft from Hawk Field or the lake at Standing Bear Lake Recreation Area shall fly in a safe and controlled manner.
- 3. When a 72 mhz transmitter is in use, a Hawk Field field permit or valid AMA membership card must be on the appropriate frequency flag. All 72 mhz transmitters must be turned off at all times, unless posted on the required frequency flag.
- 4. All R/C aircraft must meet AMA guidelines for noise.
- 5. All flying must be within the Standing Bear Lake Recreation Area boundaries and east of the safety fence at Hawk Field, with the exception of the Park Flyers Area. When flying off the lake, all aircraft must remain over the lake area.
- 6. R/C aircraft powered by internal combustion engines can be flown on weekdays from 8:00 AM to 10:00 PM and on weekends and holidays from 9:00 AM to 10:00 PM.
- 7. In the event of a Personal Injury, Property Damage, flyaways, or crashes outside the approved flying area as defined in Rule #5, a member of the Omahawks Board shall be notified within 12 hours of incident.
- 8. Turbine powered R/C aircraft are prohibited from flying at Hawk Field at Standing Bear Lake Recreation Area.

9. Airplane engines/motors must be turned off before crossing the safety fence line as the plane exits the runway.

10. FPV (First Person View) flying must comply with all AMA guidelines, including the use of a spotter.

Failure to observe these rules may result in the loss of flying privileges at Hawk Field and/or revocation of the operator's field permit.

Flying at Hawk Field and off of the lake at Standing Bear Lake Recreation Area is managed and operated by Omahawks R/C, Inc. for and on behalf of the City of Omaha

Omahawks R/C, Inc is authorized to enforce these rules

### AMA Executive Council Meeting.

### Greetings,

This month I attended the AMA Executive Council meeting and had a Leader Member Committee meeting. This Leader Member Minute will be longer than normal because there are a lot of things going on.

You and your club officers should have received an email on April 26, 2019, from AMA Government Relations about FAA air traffic control letters of agreement. If your officers have any questions about this, have them contact AMA Headquarters.

You also need to make sure that your club's contest directors

(CDs)/event managers (EMs) are up to date and know about the Large Model Airplane program and the Turbine program. The new Form 10 has additional sections in it for CDs/EMs to verify that pilots are complying with these programs. Your club CD/EM can find more information on AMA's website.

Another topic is how you are getting the information out to members who do not attend meetings. Do you have quarterly meetings or meet every six months? One suggestion is to utilize your club newsletter, club Facebook group or page, and your mailing list. This information is important, and all members should get it.

The Leader Member Committee had a great meeting and we will be rolling out phase two shortly.

# AND NOW THE LEADER MEMBER MINUTE (you may simply read this to your club)

There is still a lot of confusion about FAA registration numbers and enforcement. The following are some questions that I have received, with answers provided by Chad Budreau, AMA executive director.

(Question) What is AMA's policy on ensuring that members comply with the FAA registration rule?

(Answer) You are not FAA's enforcement agency. Your role as a club and member is to educate and encourage registration, but you should not police registration. Even law enforcement personnel are not to police registration, unless they suspect a threat, or if they are conducting an investigation. Even then, law enforcement does not have direct access to the FAA database to validate registration numbers.

(Question) If there is an incident and the club/member is sued, will AMA insurance cover the club and members, even if they did not follow the registration rule?

(Answer) We asked our legal counsel if a club could be held liable should a member not comply with the FAA registration rule. We live in a society in which anyone can sue, but our legal counsel believes that clubs could not be held accountable. In addition, the FAA would not pursue a club for a member's noncompliance in the same vein that the FAA would not penalize an airport for an individual pilot failing to renew his or her pilot's license. AMA club benefits and status are not contingent upon every member complying with the registration rule. There are some situations in which a club or CD might be asked to police/inspect registration. An example would be if a club's landowner requests that all modelers be registered. Another possible scenario would be an event held at an airport and the air traffic control tower requires inspection of registration. AMA's position is to educate and ask for compliance with the registration law, but we are not to police registration.

## June 6th Flite Test Combat Event

June 6<sup>th</sup> was a sunny Saturday and at start time of 11:00 AM, the weather was relatively nice although the Winds were very gusty sometimes exceeding 20 miles per hour. If you recall Flite Test Airplanes are made from Dollar Tree Foam Boards (DTFB), so they really are not keen flyers in heavier wind speeds. Nonetheless four pilots showed up for the event: they were Tim Peters, FT Spitfire, Skip Brown FT Tiny

Trainer (Built by Luke/Ethan Hughes), Iain & Kyle Marshall (in initially had a FT Bloody Barron, which was retired to the trees prior to the first combat contest) but participated with a foamy Spitfire he had brought along and Ethan Hughes FT Tiny Trainer.

I was grateful to have a number of folks on hand that provided assistance during the contest performing a number of Miscellaneous tasks that were needed. I like to thank them here: Rick Sessions, Tom Floyd, Dan Fitzgerald, Luke Hughes and the person counting the time of the events.

Plane preparation /setup and some basic rules for scoring are listed below:

### Plane Setup

- 1. Five to Ten Feet of leader string
- 2. Thirty Feet of crape paper of your chosen color.
- 3. Flights will be 4-minute duration.
- 4. Only limit is battery size maximum 3S electric.

### **Scoring**

- 1. You get 100 points for cutting another flyer's streamer.
- 2. You get 20 points for surviving the whole four minutes flight
- 3. You get 25 points for landing withing a 30 foot radius of the ball.
- 4. If you actually land and stop touching the ball you get 50 points.
- 5. There is a 50-point penalty for Non-Engagement.
- 6. Proposal to do up to Five rounds.
- 7. Record was set as 550 points to a gent in Virginia.
- 8. Winner will get choice of prizes, but must present his prize to someone else he chooses that is in attendance.

9. At launch, flyer's must be in the air in 30 seconds. Once airborne, the 4 minute timer begins.

Once all four planes were prepared, we sent up the first batch of planes. It was amazing to watch the planes attempting to cut the other guys Streamers while avoiding collisions, or trying to keep others away.

The first round ended with **Ethan** in the lead with 145 points, unbelievably not only was he able to cut Tim's streamer, but he got his own streamer entangled with Tim's and wound up, flying the rest of the flight pulling both streamers (See Pictures). **Tim** 

ended minus the streamer but with 45 points for completing the whole four minutes and landing within the target area. **Skip** had a very aggressive flight, and ended with 45 points for completing the whole four minutes and landing within the target area as well. **Iain** ended with 45 points for completing the whole four minutes and landing within the target area (slightly enlarged to include the runway).



The second and final round ended with **Skip** in first place, **Tim** set down with four seconds before time was called although he was in the landing circle. **Ethan** landed within the circle and completed the round. **Iain** suffered a disastrous crash midway through the round when his Spitfire went inverted then nosed into the runaway.

At the end of the contest Ethan's had more points than the rest of the flyers, and was awarded a 2/3rds completed Flite Test Simple Cub donated by Rick Sessions. Tyler received a Flite Test Mini Scout for his participation from the contest sponsor.

Lunch was provided by your Contest Coordinator from our local Arby's restaurant with assistance from Rick Sessions providing chips and Soft drinks with Luke Hughes preparing sandwiches for all contest participants, as well as Maintenance Construction Crew. Many favorable comments were given for the food selection!!





In late May, Omaha re-opened the Standing Bear Park and a few intrepid souls came out to the field to get a quick flight or two in while the weather was good and the winds low





### \*\* The Final installment in the Staggerwing – Part 3

I'm getting close to completing the Staggerwing winter (and spring) build. Overall, it's been an interesting exercise with some twists along the way. This model has one small hatch in the bottom mid-section, which would make servicing any main components impossible. However, a unique feature is the bolt-on firewall. There are 8 bolts that hold this to the fuselage. The only thing you need to do when removing it is to disconnect the throttle linkage. This then opens up the entire front-end of the airplane.



### Firewall ready for install!

I decided to finish the model with Rustoleum rattle-can paint. I've been pleased with the paint but not the results of glassing and finishing the foam-core wings and tail surfaces. I've glassed sheeted balsa in the past with good results. However, foam is much more **unforgiving** with extra sanding and filling needed for good results. Lots of imperfections (but not so many as to start over again). Lessons learned the hard way.

The color scheme is one that I saw in an aviation magazine. I masked the cowl and fuselage and applied gold paint. Callie Graphics supplied the numbers. All that's left is to finish some small items, install the windshield, and set the CG. Then it will be time for a maiden. I hope you have a good flying season in this Covid-19 year.
